

AMENDMENT No. 1 to the GRANT AGREEMENT between [Novartis] and Hudsagen

This Amendment No. 1 ("Amendment") is entered into as of December 5th, 2023 ("Amendment Effective Date") by and between [Novartis] Reg. No. 20575786, a company incorporated under the laws of Denmark, located at Edvard Thomsens Vej 14, DK-2300 Copenhagen S, Denmark ("Novartis") and Hudsagen (CVR no. 81935319) in collaboration with Advice A/S (CVR no. 20212209), an organization and a company, respectively, incorporated under the laws of Denmark, located at Blekinge Boulevard 2, DK-2630 Taastrup and Gammel Kongevej 3E, DK-1610 Copenhagen V ("[Counter-Party]"). Novartis and Hudsagen, Advice A/S are each referred to individually as a "Party" and together as the "Parties".

WHEREAS, Novartis and Hudsagen, Advice A/S are parties to a GRANT Agreement dated the 30th of August 2023 as amended on the 5th December, ([**collectively comprising**] the "**Agreement**") [concerning a financial contribution]; and

WHEREAS, the Parties mutually desire to amend, modify and restate certain terms and conditions of the Agreement [regarding Grant - Novartis' financial contribution].

NOW THEREFORE, in consideration of the premises and the mutual covenants herein contained, it is mutually agreed as follows:

1. **DEFINITIONS**

Unless otherwise defined herein, capitalized words in this Amendment shall have the meaning attributed to them in the Agreement.

2. AMENDMENTS

The Parties agree that, as of the Amendment Effective Date, the Agreement is amended as set forth in this Section 2.

2.1 [Section "Exhibit A GRANT AMOUNT & GRANT ACTIVITY" is modified in its entirety and replaced by the following:

Grant Amount: 110.000 DKK, including VAT.

3. INTEGRATION

Except for the sections of the Agreement specifically amended hereunder, all terms and conditions of the Agreement remain and shall remain in full force and effect. This Amendment shall hereafter be incorporated into and deemed part of the Agreement and any future reference to the Agreement shall include the terms and conditions of this Amendment.
